Considering the fact that the dwelling is to be constructed on a portion of the lot that Mr. Danforth is trying to prove ownership, a motion was made by AB and seconded by DB to table any action on Mr. Hammock's application until such time as Mr. Danforth has a recorded deed from the current landowner. All were in favor.

<u>Correspondence</u>: The Chairman received a letter form DEP indicating that the Department had reviewed the Town's amendment to the laterally split district and the change had been approved.
