In attendance was:

- 1 Wayne McLaughlin called the meeting to order at 19:04.
- 2 The meeting began with the Pledge of Allegiance.

3 Consent Agenda:

3.1 Approved the minutes of the Board of Selectmen dated December 20, 2010 accepted as written. (3-0).
3.2 Approved Warrant #1 totaling \$36,905.37. Approved (3-0).

Community Relations, Announcements, and Open Public Forum:

4.1 Open Public Forum :

- **4.1.1** W. McLaughlin stated that Samantha McDougal had requested her brother's jersey, which hangs at the Embden School building. Selectmen agreed. W. McLaughlin stated he would get it tomorrow.
- **4.1.2** W. McLaughlin submitted a request from E. Thebarge. C. Taylor made a motion (2nd S. Lehay) that E. Thebarge be paid in January for his April Assessors pay. (3-0) B. Baker asked whether the Selectmen wanted it added to tonight's warrant or the next one. C. Taylor replied to pay it on the next warrant.
- **D**. Dunton asked whether there would be options on the written town meeting ballot on what would be 4.1.3 done with the school. W. McLaughlin replied, "There's gonna be articles in the town report as far as I know." S. Lehay said that it would not be on the written ballot, it would be included in the open town meeting warrant. C. Taylor added that this would give the Committee a chance to report on what they had been doing for fundraisers, etc. that could be potential inflows for the building. S. Lehay stated that in his opinion, there needed to be 3 choices on the warrant: 1. Run it as a community center, 2. Run it & move the town office over there, and 3. Cut our losses & sell the building. D. Dunton stated that that was what she was wondering. She added that she felt that the committee only had one viewpoint, that of making it a community center. W. McLaughlin said, "No, no. I disagree." D. Dunton replied, "In otherwords, people if it's not presented to the people like say in the newspaper, or posted somewhere, then the're not gonna know until they come." C. Taylor stated that it was a double edged sword. D. Dunton clarified that this item would not be available unless people came to the town meeting. S. Lehay replied that he felt the people would be better able to get all the information, and ask any questions, if it were done at open meeting. He stated that he didn't know how people would get the information otherwise. B. Baker stated that if the Selectmen decided to do it on the written ballot, then they would have to hold a public hearing or informational meeting beforehand. She added that she was unsure of the timeframe.
- **4.1.4 D**. Dunton asked what the land which was purchased across from the town house was being used for. S. Lehay asked what it was originally purchased for. M. Witham replied it was purchased for a transfer station. C. Taylor stated that the town owned quite a few properties in town. He added that he felt the town needed some sort of comprehensive plan to decide which direction the town wanted to go with them. He stated that he felt the town needed an administrative assistant because, "It's big. These girls are overwhelmed with what they have to do during the day without trying to manage this company."
