Minutes of the Board of Selectpersons

November 18, 2013

19:00 PM Meeting held at the Embden Town Office

In attendance was: Scott Martin (Nitram), Wayne McLaughlin, Elizabeth Pratt, Charles Taylor, and Bonnie Baker.

- 1. Charles Taylor called the meeting to order at 19:04.
- 2. Consent Agenda:
 - **2.1.** Approved the minutes of the Board of Selectpersons dated November 4, 2013 as corrected (3-0).
 - 2.1.1. Removed specifics of H. Hinman's illness from minutes
 - **2.2.** Reviewed Warrant #22 totaling \$223,785.54. (3-0)
- 3. Appointments & Resignations:
 - 3.1.1. **RSU #74 School Board Director**: No applicants. Tabled until next meeting.
- 4. Department Officials Reports:
 - **4.1. E-911** No Report.
 - **4.2. Winter Roads Contractor** –No Report.
 - 4.2.1. E. Pratt said that her son had driven from Jackman on Friday, and Embden roads were the only ones with grit.
 - 4.2.2. C. Taylor stated that R. Dunphy had suggested setting up the turn around on the Cleveland Road.
 - 4.2.3. E. Pratt said that they had been told that the turn around on the Concord Corner Road was not level.

 - 4.4.1. T. Lamontagne stated she would like to review with the BOS how the Abatement process works. She emphasized, "Any taxpayer that comes thru the door and says [their] taxes are too high can apply for an abatement." She added that their taxes did not have to be paid in order for them to be eligible to apply, and they could get an application from the Assessors or the Town Clerk. She explained that the process works differently in different towns, but in Embden if an abatement request is denied then the taxpayer's next step would be to the County Commissioners, not the BOS, because Embden does not have a Board of Assessment Review. She stated, "I wish all town officials could get on board with that, and stop pointing these things to the BOS, because if I was a Selectman, that is one thing I would NOT want to deal with." Discussion continued.
 - 4.4.2. T. Lamontagne stated, "Another thing that has crossed my desk is the FOAA. Yes they can ask us to produce documents in a reasonable amount of time. It does not mean they can hammer us with questions. The lawyer has suggested that we urge them to appeal to the County Commissioners." C.Taylor replied, "If that is what the lawyer says." E. Pratt said, "That is what we pay the lawyer for. I say we follow his advice." W. McLaughlin stated, "It is taking away from everything else that needs to be done back there." C. Taylor recommending adding money to next year's budget for issues such as these. Discussion continued.
 - 4.4.3. C. Taylor stated, "[T. Lamontagne], don't get discouraged." E. Pratt added, "We are going to back you 110%, but we also need to have the lawyer involved."
