Minutes of the Board of Selectpersons

February 3, 2014

19:00 PM Meeting held at the Embden Town Office

In attendance was: William Atwood, Robert Dunphy, Terriann Lamontagne, Wayne McLaughlin, Elizabeth Pratt, Charles Taylor, and Bonnie Baker.

- 1. Charles Taylor called the meeting to order at 19:03.
- 2. Consent Agenda:
 - **2.1.** Approved the minutes of the Board of Selectpersons dated January 20, 2014 as written (3-0).
 - **2.2.** Reviewed Warrant #2014-003 totaling \$37,170.84 (3-0).

 - 4.4. Board of Assessors -
 - 4.4.1. **T**. Lamontagne stated they were, "lawyering back up for another abatement case." She stated that it was another issue with the map. She stated they would go in front of the County Commissioners in February.
 - 4.4.2. She asked if they could discuss the Knapp case. She asked whether they could meet with the town attorney before issuing a payment. C. 4.16.1. W. Atwood submitted estimates for work on the ECCtr:

- 4.16.2. C. Taylor stated S. LeHay had priced out the materials for the gym floor at ~ \$3K. W. Atwood said he could cut a section of floor out to determine why the floor was rising, but he didn't know if the BOS wanted to wait until after Town Meeting.
- 4.16.3. W. McLaughlin stated they needed to get rid of the snow next to the ECCtr, because it was piled up.
- 4.16.4. B. Baker asked if the ice rink was functional yet. W. McLaughlin replied, "I don't know, last I knew Scott flooded it."

4.17. Emergency Management Directors -

- 4.17.1. R. Dunphy stated, "Anson has an issue with Embden people going to the warming shelter in the Anson Fire Station. Doug Cahill says he will take them, but the new Fire Chief is fighting him about it."
- 4.17.2. He said that the ECCtr could not be a shelter because when the money was good, they made too many of them, and there is already one at Carrabec. W. Atwood asked if there was really that much need here. R. Dunphy replied, "The State doesn't think so." He added that one at the ECCtr would probably be the best one because if they are done at the school then all the towns have to pay for it; where as one at the ECCtr would just be paid for by us. W. McLaughlin asked what a warming center entailed. He asked if the ECC would have to furnish meals. R. Dunphy replied, "Probably, but if you get people from everywhere then you bill the towns that the people came from." Discussion continued. E. Pratt stated they would probably need fans in the gym. R. Dunphy said they should have them anyway.
