1. Charles Taylor called the meeting to order at 19:04.

#### 2. Consent Agenda.

- 2.1. Approved the minutes of the Board of Selectpersons dated April 21, 2014 as written (3-0).
- **2.2.** Reviewed Warrant #2014-009 totaling \$50,773.28 (3-0).
  - 2.2.1. Invoice for Michael Witham Trucking was removed from the warrant & held awaiting further information.

- 3.1. Planning Board Member & Alternates Tabled until next meeting.
- 3.2. Appeals Board Members -
  - 3.2.1. C. Taylor made a motion (2<sup>nd</sup> E. Pratt) to appoint Mary Keenan as an Appeals Board Member. (3-0)
- **3.3.** RSU74 School Board Director Tabled until next meeting.
- 3.4. Town Fire Warden E. Pratt made a motion (2<sup>nd</sup> W. McLaughlin) to appoint Robert Dunphy as Town Fire Warden (3-0)

#### 4.1. E-911 -

4.1.1. E. Pratt noted that E. Ketchum had called to report that she had ordered signs.

4.2.1. **C.** Taylor declared that he had instructed F. Nile to back drag Billy's lawn, as well as the Town House lawn. He added that F. Nile had also installed the dock while he was there.

- 4.5.1. L. Mayo reported that he had submitted paperwork for the STM. He stated that they had received the updated map from Sackett & Brake, however it was "not quite right." BOS reviewed information.
- 4.5.2. He advised that Myles Durkin had attended training in Skowhegan the other night.
